As per Section 11 through 14 of the enclosed copy of the WBO Rules and Regulations of World Championship Contests (www.wboboxing.com), please be advised that a Purse Bid will be held at 12:00 p.m. (Noon) (Atlantic Standard Time) on Tuesday, June 1, 2021, at the World Boxing Organization Headquarter offices.

Please be advised that the minimum Purse Bid for the WBO Flyweight Division is \$80,000.00 (Eighty Thousand Dollars).

Purse bid proceedings for WBO World Championship Contests shall be distributed as follows:

(1) CHAMPIONSHIPS WITH AN EXISTING CHAMPION

- (A) In fights between the **Champion** and the first available contender held in the country of origin, residence or nationality of the Champion, or a neutral venue, the **Champion** shall receive 75% of the total purse, and the **Challenger** shall receive the remaining 25%.
- (B) In fight for the title held in the country of origin, residence or nationality of the **Challenger**, the **Champion** shall receive 80% of total purse and the **Challenger** shall receive the remaining 20%.

Please be advised the parties shall comply fully with the WBO Championship Rules and Regulations of World Championship Contests regarding Purse Bid procedures.

The WBO President, Mr. Francisco "Paco" Valcárcel, Esq., will preside proceedings.

Lastly, please be advised on the following provisions:

1. If the Champion is injured and depending on the type of injury and needed recovery time, or if the Champion is unavailable to fight for whatever reason, the WBO Championship Committee may issue any ruling, including but not limited to ordering an Interim Championship Contest between the first available contenders selected by the Committee, or any other ruling in accordance with our rules for purposes of keeping the WBO Flyweight Division active.
2. If the Challenger is injured and depending on the type of injury and needed recovery time, or if the Challenger is unavailable to fight for whatever reason, the Committee shall proceed with selecting the first available contender in the Flyweight Division to contest for the WBO Flyweight Championship.
3. The parties have 5 days upon the adjudication of the purse bid to file duly executed bout agreements with the WBO main offices.
4. The Nakatani/Acosta bout shall take place no earlier than 45 or later than 90 days from the purse bid's adjudication.
5. The winning bidder has 48 hours upon the adjudication of the purse bid to wire transfer the purse bid service fees and the 10% of the total purse offer to the WBO. Non-compliance with this condition will result in this Committee declaring a default on the winning bidder and adjudicating the bid to the second-highest bidder.
6. The WBO World Championship Committee reserves the right to issue any and rulings deem necessary, helpful, and convenient to accomplish the purposes, policies, and intent of our rules and principles.
