There are certain guidelines that can be found on our website [www.wboboxing.com](http://www.wboboxing.com) and should be known by all WBO Champions and former champions. These guidelines have been created to rate boxers in an "objective and consistent manner" that will maintain the boxers prominence on the world ratings. The WBO Criteria also follows the guidelines of the **ABC Championship Contests Rating Criteria** and expects boxers to comply with both.

According to the **WBO Regulations of World Championship Contests,**

## **SECTION 8 CRITERIA TO MAINTAIN RATING AS A CLASSIFIED FIGHTER**

- (a) To keep his position on the official WBO classification list and to be eligible to be designated by the World Championship Committee as the Mandatory Challenger, contender number 1 and contender number 2 shall defend his classification at least annually against any of the classified contenders in his weight category, according to the current list of classifications promulgated by the Classifications Committee, and he shall comply with the Association of Boxing Commissions Criteria for Ratings of Professional Boxers. If contender number 1 and/or contender number 2 fails to comply with this Rule, contender number 1 and/or contender number 2 may lose his classification. **It is the responsibility of each classified boxer to know the WBO and ABC Criteria for Ratings, to meet the WBO Regulations of World Championship Contests...**"
