Re: WBO Middleweight Champion Dmitry Pirog and WBO Interim Champion Hassan N'Dam N'Jikam

Dear Champion Pirog:

Dmitry Pirog was inactive to the extent that an interim championship was ordered by the WBO Championship Committee on May 4, 2012. This was won by N'Dam N'Jikam. Under the WBO Rules Dmitry Pirog is required to fight a mandatory with Interim N'Dam N'Jikam. A purse bid was ordered, but it was determined by Dmitry Pirog that he would not fight N'Dam within the terms of the World Championship Committee Resolution that Dmitry Pirog shall fight the WBO Interim Champion as his next match and that be concluded within 120 days of May 4, 2012.

Dmitry Pirog has requested that he retain the WBO Middleweight Championship until his August 25, 2012 bout with Gennady Golovkin for the WBA Middleweight world titles, and that he be allowed to enter the ring on August 25 as the WBO Champion, and that the WBO Championship be vacated at the start of that match.

The World Championship Committee hereby grants that request, with the understanding that at the start of the August 25th bout against Gennady Golovkin, or even if the bout does not take place, Dmitry Pirog shall vacate his title and that Hassan N'Dam N'Jikam shall be the WBO Middleweight World Champion in any event as of August 25, 2012.
