As per Sections 11 through 14 of the enclosed copy of the WBO Regulations of World Championship Contests ([www.wboboxing.com](http://www.wboboxing.com)), please be advised that a Purse Bid will be held at 10:00 a.m. Eastern Standard Time (EST) on Wednesday, January 29, 2020 at the Nautilus by Arlo Hotel, Miami, Florida, United States of America.

Pursuant with the WBO Regulations of World Championship Contests on Purse Bid proceedings, kindly be advised on the following:

**The minimum acceptable bid in the Jr. Middleweight Division is two-hundred thousand US dollars (\$200,000.00).**

WBO President Francisco Valcárcel, Esq., will preside proceedings.

Kindly note the following provisions:

1. If the WBO Champion is injured and depending on the type of injury and needed recovery time, the WBO World Championship Committee, per the WBO Regulations, will determine if the WBO Championship title is declared "Vacant", or an Interim WBO Championship contest is ordered.
2. If the Challenger is injured or refuses to fight, he loses his position in the WBO World Ratings. Accordingly, the WBO World Championship Committee may determine and select the next available contender or orders an Elimination bout between the two best available contenders, and the WBO Champion may be permitted a voluntary defense.
3. Signed contracts shall be filed with the WBO's main offices within five (5) days upon the adjudication of the Purse Bid.

Section 13 (a) subsections (1)(A) and (B) of the WBO Regulations of World Championship Contests provides:

**(1) CHAMPIONSHIPS WITH AN EXISTING CHAMPION**

- (a) In fights for the title between the Champion and the Mandatory Challenger held in the country of origin, residence or nationality of the Champion, the Champion shall receive 75% of the purse, and the Challenger shall receive the remaining 25%.
- (b) In fights for the title held in any other country, the Champion shall receive 80% of the purse, and the Challenger shall receive the remaining 20%

Please be advised that the parties must comply fully with the WBO Regulations of World Championship Contests regarding Purse proceedings.
