Dear Mr. Beniamino:

Please be advised that on October 8th, 2019, Mr. Carl Moretti, on behalf of Top Rank, Inc., requested that WBO Female Jr. Lightweight Participant Ms. Mikaela Meyer be designated Mandatory Challenger in the referenced division.

Conversely, on January 17th, 2020, this Committee issued a sanction approval letter for the WBO Female Jr. Lightweight Championship between current champion Ms. Ewa Brodnicka and Ms. Djemilla Gontaruk. This bout was held on Saturday, March 7th, 2020, in Dzierzoniow, Poland, and subject to the winner facing her WBO Mandatory Challenger designated by the WBO within 120-days after the Brodnicka/Gontaruk bout per WBO Rules and Regulations. Ms. Brodnicka was successful winning via unanimous decision (UD).

Whereas, again, on February 6th, 2020, the WBO confirmed the request by Mr. Carl Moretti on behalf of Top Rank, Inc., that WBO Female Jr. Lightweight Participant Ms. Mikaela Meyer be designated Mandatory Challenger in the division mentioned above, and negotiations are ordered between the parties. Wherefore, in light of the preceding, this Committee hereby designates WBO Female Jr. Lightweight Participant Ms. Mikaela Meyer Mandatory Challenger in the WBO Female Jr. Lightweight Division and consequently, grants the parties 10-days upon receipt of this letter to negotiate and reach an agreement accordingly.
