Re: Show Cause - WBO Female Jr. Flyweight Champion – Ms. Seniesa Estrada

Dear Mr. Gomez:

The WBO World Championship Committee hereby grants WBO Female Jr. Flyweight Champion, Ms. Seniesa Estrada five (5) days upon issuance of this notice letter to "*Show Cause*" why the Committee shall not declare the WBO Female Jr. Flyweight Championship Title "Vacant" due to holding simultaneously in different weight divisions the WBA Minimum Weight and the WBO Female Jr. Flyweight Championships in contravention with WBO Regulations of World Championship Contests. See, Sections 5(d) and 15 of the WBO Regulations of World Championship Contests

As you are aware, Ms. Estrada is scheduled to defend her WBA Minimum Weight Championship Title against Ms. Santizo on Saturday, December 18, 2021, at the AT&T Center in San Antonio Texas. Per WBO Rules and Regulations, no WBO Champion may hold titles in more than one (1) weight division nor may hold a non-WBO Championship in a weight class that is different from the weight class of his WBO Championship.

Considering the foregoing, be advised that Ms. Estrada shall decide within the time frame stated herein which weight division will retain, or the WBO World Championship Committee will proceed in accordance with its governing rules. Failure to comply with this order will result in Ms. Estrada waiving all rights hereunder and having the Committee declaring the WBO Female Jr. Flyweight Championship Title "Vacant" "Ipso Facto" without further notice and/or hearing.

Lastly, the Committee reserves the right to issue any rulings necessary, helpful, and convenient to accomplish the purposes, policies, and intent of the WBO Regulations.
