Re: Show Cause Notice – WBO Jr. Middleweight Champion – Brian Castaño

Gentlemen:

Please be advised that the WBO World Championship Committee confirmed receipt of email correspondence dated Wednesday, February 16, 2022, by Mr. Matt Rose of "No Limit" Promotions and representative of Jr. Middleweight Mandatory Challenger and Global Champion Tim Tszyu indicating that TGB Promotions informed Mr. Rose that the Undisputed WBO, WBA, WBC & IBF Jr. Middleweight Championship Contest between Jermell Charlo and Brian Castaño scheduled for Saturday, March 19, 2022, at the Crypto Arena, in Los Angeles, California had been canceled due to an injury suffered by Brian Castaño, and therefore, Castaño is unavailable to participate as scheduled. Consequently, TGB Promotions informed Mr. Rose that the Charlo/Castaño would be rescheduled for either the months of May or June of 2022. (See, Enclosed E-mail correspondence filed by Mr. Matt Rose to the WBO dated February 16, 2022)

Considering the preceding circumstances and Mr. Rose's objection that the WBO Mandatory title defense is further delayed, he requests that this Committee proceeds with the immediate enforcement of the WBO Mandatory title defense between Brian Castaño and Tim Tszyu accordingly.

Therefore, having this Committee considered the above facts and circumstances, having reviewed our governing rules and regulations as well as all relevant resolutions or agreements pertaining to the Charlo/Castaño bout, TGB Promotions has 24 hours upon issuance of this notice letter to **"Show Cause"** why the WBO World Championship Committee shall not order the enforcement of the Mandatory Title Defense between Brian Castaño and Tim Tszyu, and order negotiations immediately between the parties.
