- 1. The Committee unanimously recommended to the WBO Executive Committee to strip John Riel Casimero's WBO World Bantamweight Championship Title for failure to comply with the conditions set forth in its "Resolution."**
- 2. The WBO Executive Committee unanimously voted in favor of adopting the WBO Championship Committee's recommendation and therefore declares the WBO Bantamweight Championship Title "Vacant."**
