Re: Undisputed WBO, WBA, WBC & IBF Jr. Middleweight Championship Contest Brian Castaño vs. Jermell Charlo

Dear Mr. Brown:


The WBO World Championship Committee hereby grants sanction approval for the above-referenced bout between Unified WBA, WBC, & IBF Jr. Middleweight Champion Jermell Charlo and WBO Jr. Middleweight Champion Brian Castaño, to be held on Saturday, May 14, 2022, at the Dignity Health Sports Park, Carson, California, United States of America.

Furthermore, the Charlo/Castaño bout is sanctioned subject to (i) the winner of Charlo/Castaño must face within 120 days after the bout the WBO Jr. Middleweight Mandatory Challenger designated by the WBO World Championship Committee; (ii) the winner of Charlo/Castaño and the Mandatory Challenger have 10 days upon the conclusion of the Charlo/Castaño bout to negotiate and reach an agreement, or purse bid proceedings will be ordered per WBO Regulations of World Championship Contests; and (iii) the Commission's (CSAC) physician must certify in writing to the WBO that Charlo & Castaño are medically fit and able to compete as scheduled.

Additionally, sanction approval is subject to full compliance with all the conditions set forth in this Committee's "Resolution" dated March 3, 2022, which are incorporated by reference and state the following (i) fight must take place no later than Saturday, May 14, 2022; (ii) if the fight does not take place regardless of the circumstances attributed to Brian Castaño, the WBO Jr. Middleweight Championship Title will be declared "Vacant" automatically "Ipso Facto" and sanction approval is terminated "Ipso Facto;" and (iii) if Jermell Charlo suffers an injury or is unavailable to fight whatever reasons, the WBO Jr. Middleweight Champion must fight the WBO Mandatory Challenger immediately in his next bout.

Lastly, this Committee reserves its right to issue any further rulings deem necessary, helpful, and convenient to accomplish the purposes, policies, and intent of the WBO Regulations of World Championship Contests, including serving the best interests in boxing and those in Jr. Middleweight Division.
